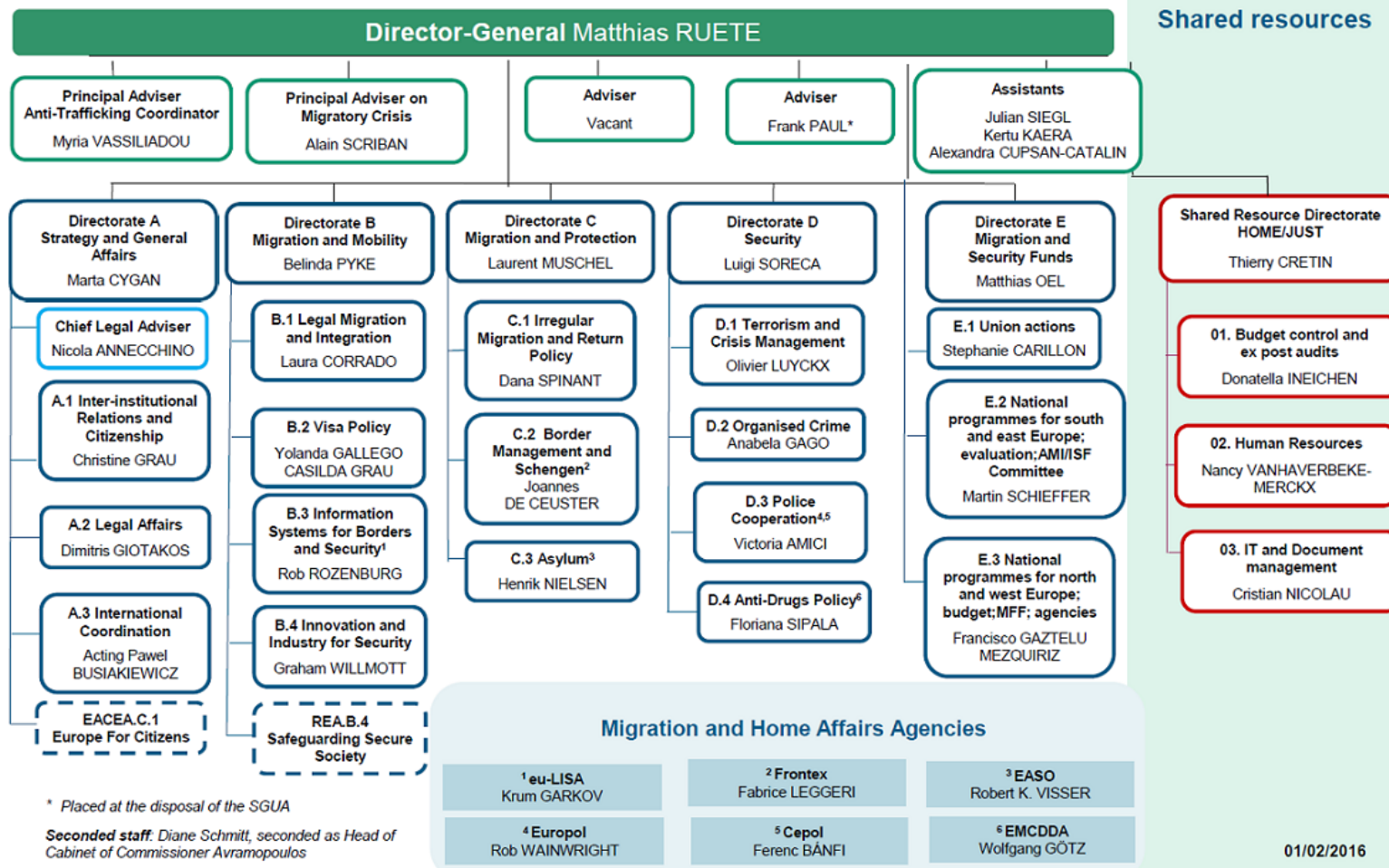

UNION ACTIONS

Legal basis – Union actions

- **AMIF** – Article 20 of Regulation (EU) 516/2014
- **ISF-borders** – Article 13 of Regulation (EU) 515/2014
- **ISF-police** – Article 8 of Regulation (EU) 513/2014
- **Horizontal** – Articles 6 and 8 of Regulation (EU) 514/2014

Scope of Union actions (1)

- **Transnational projects - sharing best practices, cooperation networks**
- **Studies, statistical tools, evaluation of policies**
- **Actions in relation to third countries**

Scope of Union actions (2)

Must be related to the objectives defined for the three instruments:

- asylum, legal migration, integration, return**
- border management, visas**
- combating crime, protection of critical infrastructure**

Examples of actions - AMIF

- **Call for proposals** – integration; monitoring of forced return; return of victims of trafficking in human beings
- **Regional Development and Protection Programmes for North Africa and the Horn of Africa** (IT + UNHCR + IOM; NL + UNHCR)
- **Information campaigns in Ethiopia, Sudan, Niger** (UNHCR, IOM)
- **Readmission Capacity Building Facility** (IOM)

Example of actions – ISF-borders

- **Exchange of the situational picture of neighbouring external border sections between the national coordination centres of Portugal and Spain – II phase** (direct award – PT GNR)
- **Call for proposals restricted to Member States for a field experiment on the creation/management of a Schengen Masterlist** (PT SEF)

Example of actions – ISF-police

- **Direct award of an action grant to support the activities developed by a transnational law enforcement network – *Maritime Analysis and Operations Centre – Narcotics* (MAOC-N)**

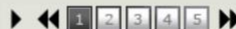

Financing

For the years 2014-2020, the overall Home Affairs budget amounts to EUR 10.52 billion. The largest part of these resources consists of two big Home Affairs Funds and the remainder (EUR 2.36 billion) is reserved for the funding of the Home Affairs Agencies.

With an overall budget of EUR 6.9 billion, the Asylum, Migration and Integration Fund and the Internal Security Fund will finance actions supporting EU Home Affairs policies in the period 2014-2020 and through these actions build a more open and secure Europe.

In the implementation of the actions in the fields of asylum, migration and integration and internal security and borders supported by these two Funds, the Commission will work closely together with EU States. For actions carried out at EU level, the Commission will also directly cooperate with international and civil society organisations via grants and public contracts that are awarded through calls for proposals and procurement procedures respectively. At times, also calls for experts are organised to provide opinions and advice on specific topics.

As of 2015, DG Migration and Home Affairs manages also the funding for research and innovation activities needed to protect our citizens, society and economy as well as our infrastructures and services. Such activities are funded under one of the Societal Challenges of Horizon 2020, EU Research and Innovation programme running from 2014 to 2020. The Societal Challenge "Secure societies – Protecting freedom and security of Europe and its citizens" has a budget of about 1.7 billion Euros until 2020, which is divided between DG HOME (75% of the budget), and DG CNECT (25% of the budget).

At the same time, Europe for Citizens programme with the aim to contribute to citizens' understanding of the EU, its history and diversity and foster European citizenship and improve conditions for civic and democratic participation at EU level became part of the DG portfolio.

Internal Security Fund – Borders and Visa

Part of the ISF Borders and Visa Fund is managed by the Commission (direct and indirect management) through Union Actions, which can include calls for proposals, procurement, direct awards and delegation agreements.

For these actions the Commission approves Annual Work Programmes that define the priorities and objectives for each year, including the priorities for the calls for proposals.

EMERGENCY ASSISTANCE

Legal basis – emergency assistance

- **AMIF** – Article 21 of Regulation (EU) 516/2014
- **ISF-borders** – Article 14 of Regulation (EU) 515/2014
- **ISF-police** – Article 10 of Regulation (EU) 513/2014
- **Horizontal** – Articles 7-8 of Regulation (EU) 514/2014

Scope – Emergency Assistance

Financial assistance to address urgent and specific needs in the event of an emergency situation.

The definition of the emergency situation specific for each instrument:

- migratory pressure**
- pressure at external border**
- security-related incidents**

Alternatives to emergency assistance

- **ALWAYS**: first explore possibilities under national AMIF and/or ISF programme!
- Other funding sources, e.g.:
 - European Social Fund (ESF)
 - European Regional Development Fund (ERDF)
 - European Agricultural Fund for Rural Development (EAFRD)
 - Fund for European Aid to the Most Deprived (FEAD)
- EU Civil Protection Mechanism
- Only when no other options → emergency assistance

Example of actions

- ***SUPPORT TO GREECE FOR THE IMPLEMENTATION OF THE HOTSPOT/RELOCATION SCHEME & FOR THE INCREASE OF THE ASYLUM RECEPTION CAPACITY*** (indirect management UNHCR)

Implementation modalities

- **Direct management** – grants awarded without calls for proposals to Member States or international organisations
- **Indirect management** – budget implementation tasks entrusted to international organizations
